KEY DISCUSSION & DECISIONS

Topic: Call to Order

Summary: President called the meeting to order.

Topic: Treasurer Report

Summary: Verbal report given by Mindy (cash on hand and fish stocking balances were mentioned. Established a Venmo payment for dues. Some dues were collected at the meeting. Five year payment was made for Association website. Payment was made to rent the Jackson town hall.

Topic: Elections

Summary: Open positions (Treasurer, Vice President, Directors at large. The Treasurer position transitioned but needs membership approval. Don said he would send out ballots for the open positions. A verbal solicitation of the membership was made for open positions. A question was asked about who can qualify to hold a board position (check by-laws).

Topic: Fish Sticks

Summary: Discussion on the current status of the fish stick program and its benefits. Additionally fish cribs were mentioned. No one was sure if the State of Wisconsin is still supporting a program and it would require submitting a written request for funding. No final decision was made on the program.

Topic: Fish Stocking

Summary: Open discussion on the benefits and schedule for fish (Walleye) stocking. Stocking of fish is in the Fall (Sept) and we would need volunteers to help. Funding is available through membership

donations. Two years ago the price was \$2K for 1K of fish. Stocking is coordinated with other lakes in the area.

Topic: New Owners
